Senate Bill 32 - The Pregnancy Resource Act (a Pro-Life Tax Credit Bill) - Please call your SC House Representative and tell them to vote YES for passage S. 32. Once passed, it would provide a SC tax credit to those who contribute to charitable organizations that provide adoption services, prevent abuse, neglect, or abandonment; prevent trafficking of children and provide assistance related to carrying a pregnancy to term, preventing abortion, and promoting healthy childbirth.

- --The **Tennessee Genomic Security and End Organ Harvesting Act**, <u>unanimously passed</u> earlier by both chambers of TN's legislature, addresses the concerns with Beijing's potential access to Americans' genomic data collection as well as complicity with the regime's state-sanctioned forced organ harvesting.

Tennessee has enacted legislation—effective Jan. 1, 2026—to stop health insurance coverage for human organ transplant surgeries linked to China, becoming the fourth state to act against the Chinese Communist Party's (CCP) killing-for-organs scheme. Texas, Utah, and Idaho have previously endorsed similar measures. In Congress, bills such as the Stop Forced Organ Harvesting Act, the Falun Gong Protection Act, and the BLOCK Act seek to curb systematic abuse in China through sanctions and federal reimbursement.

Planned Parenthood & SC Update

- --U.S. Supreme Court In 2018, Gov. McMaster's executive order prevented SC taxpayers from paying for abortions. Gov. McMaster stated, "Taxpayer dollars should never fund abortion providers like Planned Parenthood. In 2018, I issued an executive order to end this practice in South Carolina. I'm confident the U.S. Supreme Court will agree with me that states shouldn't be forced to subsidize abortions. Planned Parenthood is trying to get Medicaid dollars paid by taxpayers by calling itself "a qualified medical facility". In order to get this money, they have now gone to the U.S. Supreme Court. Please pray Gov. McMaster's executive order is upheld so that Medicaid dollars truly go to "qualified medical facilities".
- --SC Supreme Court Planned Parenthood is trying to change the six-week Heartbeat Law (which was based on the cardiac activity of an unborn child at six weeks) to nine-weeks so they have the opportunity to abort a child sooner -- at 6, 7 or 8 weeks. Their arguments were heard before the SC Supreme Court, however, there is no timeline for a decision from the court. Pray that babies' lives will continue to be safeguarded by the six-week Heartbeat Law.
